Dear Members,

Looking back over the last year, the two highlights of the Society's activities were the panel at the GSA (German Studies Association) in Montreal in October and the panel at the MLA (Modern Language Association) a few weeks ago in Philadelphia. Given our small membership, it is reassuring to be able to boast this level of activity and we should try to keep up the momentum.

While we are dwarfed in numbers by the demographics of the Goethe Society of North America and the Lessing Society, the numerical proportions of the respective memberships seem to reflect the canonical ranking of the respective authors in almost comically exact proportional manner. In this respect, I am happy to report, we don't come off too shabbily.

More seriously, I believe that continuing the recruitment of new members must remain a priority, and not just for the sake of the future of the Society. I believe that engagement with one of Germany's most inspiring and resourceful exponents of modernity continues to hold the promise to serve as a most valuable source for renewing – for rethinking and reimagining – our various fields in creatively forward-looking ways. To say it with John Lennon: I might be a dreamer but I am not the only one. Put differently: Facing the pressures to rethink our fields in an age when the humanities are under acute siege, we need to return with new resolve to one of the most inspiring champions of modern literary imagination whose whole project consisted in doing just that in his own métier.

Drawing inspiration from Heine keeps this Society going. Sharing our source of enthusiasm more resolutely might not just be a lifeline for ourselves and what we do but might ultimately prove Heine once again to be strikingly more contemporary than his canonical status would suggest. With an occasional touch of the uncanny Heine's contemporaneity shows not the least because his oeuvre has remained largely resistant to instrumentalization by national and political interests and for canonical appropriation.

Another highlight showcasing how Heine stands out as a critical voice of enduring significance is the forthcoming volume of the *Heine-Jahrbuch* featuring the proceedings of the 2022 conference on

Heine and human rights co-organized by the folks in Düsseldorf and the NAHS. The publication is a bit delayed and now the publisher's site indicates April 2024 as date of release. But the section with contributions by Sebastian Wogenstein, Christoph auf der Horst, Helge Dedek, Christian Liedtke, Tracie Matysik, Christine Frank, and myself (in the order of the articles) is a solid 160 pages and, more importantly, offers some innovative perspectives on Heine and the question of Human Rights.

GSA panel Montreal 2023

At the GSA in October 2023, the NAHS participated after some time again with its own panel. Thanks to Abigail Gillman and Michael Swellander for organizing this great inaugural session on "Heine and Translation." Here is the program:

The panel's focus on translation opened a window onto previously unexamined chapters in the reception history of Heine's early poetry in French, Hebrew, Turkish, and English, particularly Heine's role as an aesthetic and political touchstone in theorizations of national literature and of literary modernism. A common focus of the papers was on the careers of Heine's translators and how Heine often served for them not just as an object of translation but as an interlocutor in their theory and practice of writing and translating poetry.
